CRB Warranty: Fast Foamer System provides a warranty specific to modifications made to the CRB for foam distribution. Coverage under this warranty is limited exclusively to components added to modify the CRB, namely the mixing box and internal foam distribution plumbing. The original CRB, as delivered, is covered by the manufacturer's warranty for a period of 90 days.

TERMS & CONDITIONS FOR CART & CRB WARRANTIES:

Duration: This Limited Lifetime Warranty is applicable for the expected service life of the system and is exclusively for the original purchaser. It does not extend to subsequent owners or third parties.

Chemistries: The validity of this warranty is contingent on the use of Foaming Floors specified chemistries, namely: Foaming Floors, High Energy Foam, Foam Armor, and Green High Energy Foam.

Proof: If requested, the original purchaser must provide proof of purchase of the Fast Foamer System and the aforementioned Foaming Floors chemistries. Moreover, Foaming Floors cleaning chemistry consumption must be consistent or applicable to the system's use, serving as a confirmation that the specified chemistries are used exclusively with the system. Foaming Floors reserves the right and has the discretion to determine satisfactory use or consumption levels for the warranty to remain valid.

Shipping/Freight: Costs related to shipping or freight for warranty service are not covered. However, Foaming Floors reserves the right to make decisions related to shipping at its discretion.

Please note: The aforementioned warranties are specific to the terms and conditions listed. It is essential to retain the original purchase receipt and any relevant documentation for validation. For any warranty claims or service-related queries, please contact our dedicated customer service team.
